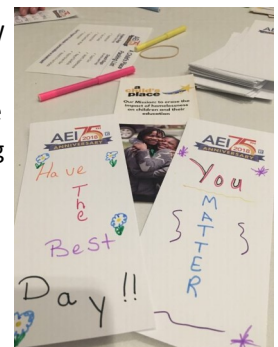

Participants (Brokers)/Subscribers (Agents) **MUST** contact board office to request a **Temporary Off Market Status**; Status shall not exceed 30 days; Temporary Off Market cannot be added within the first 14 days of obtaining all necessary signatures. If property needs to be off market longer than 30 days, must be withdrawn.

**Note1. Temporary Off Market status must be requested using the Temporary Off Market Status Request form.**

## *Legislative Updates*

### Candidate Forum for Eau Claire City Council Spring Elections

Eau Claire City Council elections will take place on Tuesday, April 3rd, 2018. Each candidate is running for a seat with 3-year term, save the at-large seat which is for a 1-year term.

The Candidates on the ballot are: Tim Tewalt and Emily Berge in District 1; incumbent David Klinkhammer and Emily Anderson, District 2; Mitchell and Jeremy Gragert, District 3; incumbent Bob Von Haden and Jill Christopherson, District 4; and Terry Weld (a fellow Realtor®) and Zachary Meives, at-large. Andrew Werthmann is running, unopposed, to continue on as representative for District 5.

The Chippewa Valley Technical College, WQOW, and Valley Media Works put on a candidate forum on Thursday, March 15, 2018. Nearly 100 people joined me at the CVTC Business Center to listen to the candidates tell us why they are choosing to run for city council. They then received two minute turns to answer four questions regarding four living wages, Sonnentag Event and Recreation Complex, tax-increment financing districts and the future of transit. The candidates took strong stances on the issues and conveyed their passions for working for the citizens of Eau Claire.

Nearly every candidate showed their support for the TIF, tax-increment, district system, stressing that it has had positive benefits and just needs to be used responsibly, as they say the city has been doing already. The issue of the Living Wage, however, did not receive quite as overwhelming support. Candidates stressed that while the city should be a leader in providing employees living wages, it is not as simple of an issue as it seems. It was also pointed out that the living wage ordinance, which was previously tabled, only effects a small amount of employees and that all full-time employees of the city are already receiving at least a living wage.

On the subject of transit, Council member Adrew Werthmann stressed that “everyone is going to tell you they support transit and they support more people getting on the bus, but, when we took a hard vote on this, many people didn’t vote the right way.” He is referring to the vote to decide to raise bus fares by twenty-five cents. Other council members who had voted in favor of the fare increase, showed their dismay at the suggestion. Councilwoman Kathy Mitchell said “that’s absolutely ridiculous.” Candidates stressed the need for a balance of low fares with budgeting concerns. One “in the works” idea that was mentioned several times was the possibility of implementing a reduced fare for low income individuals. Other candidates mentioned various solutions, such as Tim Tewalt who suggested “look[ing] at other options – smaller vehicles, more vehicles; if we take a model like Uber and Lyft, and we apply that to civic transportation.” Transportation was a key issue at the forum, particularly due to the city’s newly received five million dollar grant.

*Many viewpoints were presented at the forum—but, regardless of yours, if you live in one of these districts, don't forget to vote on April 3<sup>rd</sup>!*

- Grants are awarded in \$1000 increments. If repairs are beyond this, applicant is responsible for the remaining balance.
- Grants are awarded twice a year - typically May and September.
- Grant recipients will be alerted by mail to the submitting clergy, Human Services employee or RANWW member.
- All applications are kept confidential.

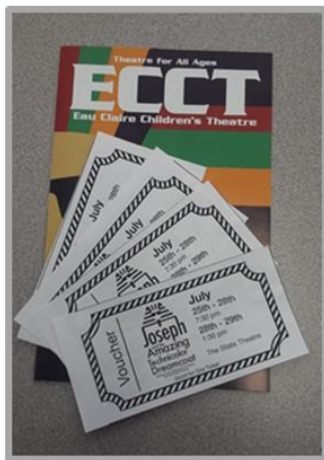
