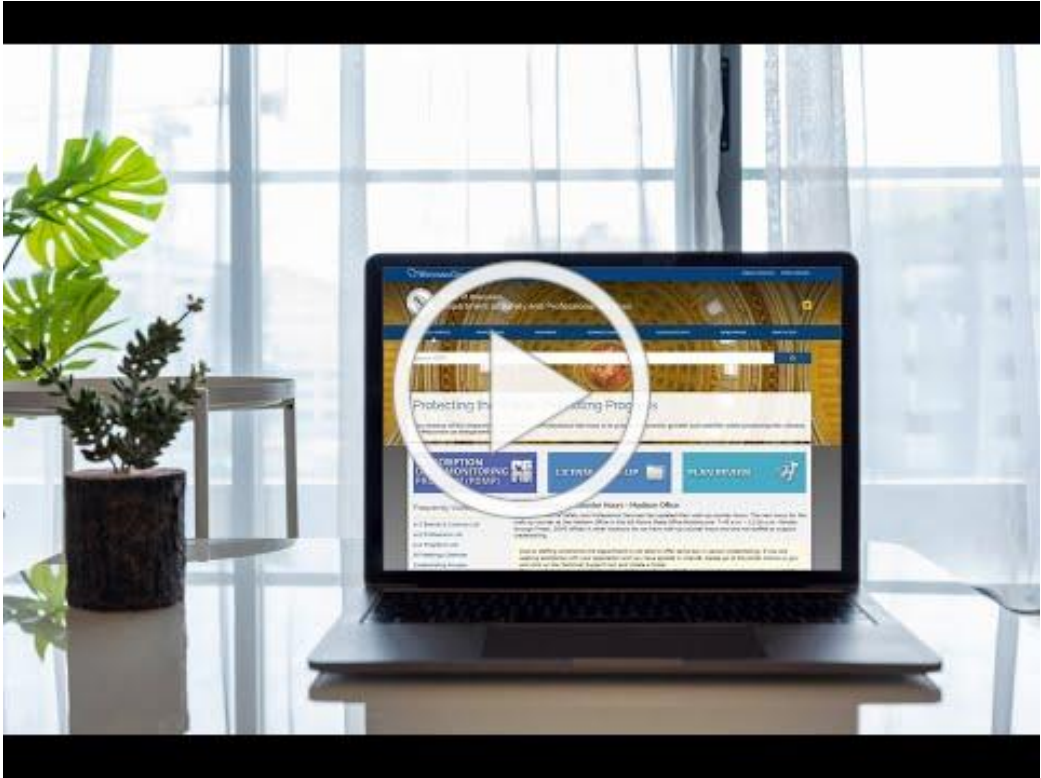
Continued Education Requirement
